- (a) To qualify, the recipient requires financial assistance in order to continue his or her studies.
- (b) Applicants are judged on the basis of financial need, character and commitment to educational pursuits.
- (c) The recipient shall be an applicant who has been accepted for a regular course of study, or a student presently attending college at the undergraduate level, or technical or vocational school.
- (d) Students may reapply for this scholarship each year that they are undergraduate students.
- 2. The award will be given during a worship service of the Peapack Reformed Church. The recipient is expected to attend the award service.
- 3. All information, including application form, transcript, and three letters of recommendation must be <u>submitted in one packet</u> by Tuesday, April 22, 2024. The information is for the exclusive use of the Scholarship Committee. It must be addressed to the Arntz Scholarship Committee Chairperson Kristina Lasher, c/o Peapack Reformed Church, Box 253, Gladstone, New Jersey, 07934, and be delivered to the church by Monday, April 22, 2024 or postmarked no later than Tuesday, April 22, 2024.
- 4. If the packet is delivered late, postmarked after Monday, April 22, 2024, or if it is not properly and fully completed, then the candidate will not be considered for the Scholarship.
